Water:

Continuing to pursue complete elimination of numerous air and water polluting substances and industrial waste based on its philosophy of using the world's leading technologies to minimise negative environmental impact.

Air:

Participates in a trail emissions trading scheme which began in 2008.

A goal was set to limit the amount of CO2 emissions per tonne of paper produced. By bringing online the mill's biomass generator and the conversion of boilers to natural gas, its targets were achieved for the first year, and further reductions will be met as the trial continues.

Solid waste land filled:

Energy:

Actively uses natural gas which generates less carbon dioxide than petroleum and coal (1.4 and 1.8 times respectively that of natural gas). The mill do not use coal, and combined with their improved facilities, control CO2 generation to about 60% of the average amount generated in the industry.
